TERMS AND CONDITIONS

1. ELIGIBILITY

- a. Residency Policy: All students must be a resident of the United States and be at least 18 years old at the time of enrollment.
 - i. A student who is a member of a religious organization or a member of a fraternal organization may be exempt from the residency policy.
 1. A student who is a member of a religious organization.
 2. A student who is a member of a fraternal organization.
 3. A student who is 24 or older.
 4. A student who is a member of a religious organization or a member of a fraternal organization and is at least 24 years old.
 5. A student who is a member of a religious organization or a member of a fraternal organization and is at least 24 years old and is a member of a religious organization or a member of a fraternal organization.
- b. Credit Hours: A student must be enrolled in at least 12 credit hours per semester.
 - i. A student who is a member of a religious organization or a member of a fraternal organization may be exempt from the credit hour requirement.
 - ii. A student who is a member of a religious organization or a member of a fraternal organization may be exempt from the credit hour requirement.
- c. Financial Aid: A student must be eligible for financial aid.

2. PERIOD OF CONTRACT

- a. The contract period is from August 15, 2024, to August 15, 2025.
 - i. A student who is a member of a religious organization or a member of a fraternal organization may be exempt from the contract period.
 - ii. A student who is a member of a religious organization or a member of a fraternal organization may be exempt from the contract period.
